
April Meeting


Electronic Materials & Computers Charity Raffle

What's New...

Intel Pentium III

Intel's newest and fastest performance microprocessor for the business desktop has the following features:

- •70 new instructions
- fast processor clock speeds of up to 500MHz
- •100 MHz bus system
- •512 KB Level 2 cache
- dynamic execution
- MMX technology
- •compatibility with the Intel 440BX chipset
- •Built-in processor serial number to enhance system security and asset tracking.

There is, however, a problem in that it is mistaken for a Pentium II processor by Windows 95 and 98. Windows system folders will identify the Pentium III as a Pentium II.

However, Windows 98 does fully support the new chip and will take advantage of the new "Katmai" instructions in the Pentium III chip that are designed to speed up multimedia and com-

munications functions, although Windows 95 cannot.

Most users will not notice the difference since the better Katmai instructions, which are not used by most software, are not used by any old software. Also, most users will not notice the difference since companies that develop BIOS software which identifies the processor for the user during the boot-up process are expected to update this software by the time the Pentium III processor is available for retail sale as a stand-alone item.

AMD Cuts Prices

Advanced Micro Devices Inc. has cut prices on its K6-2 processors in an effort to match Intel price cuts for Celerons. With the new cuts, the volume price of AMD's K6-2 match the volume price of Intel's Celeron processors at the same clock speeds. This reduces the price of the K6-2 to more than 25 percent less than Pentium II chips running at the same clock speed.

Although the prices are the same, the K6-2 offers more technology than the Celeron. The AMD chips can run with a system bus as fast as 100 MHz. The system bus,

which serves as the main conduit between the processor and main memory, runs at only 66 MHz on the Celeron and won't likely move to 100 MHz until 2000 according to Intel executives. Additionally, the K6-2 processors come with 3D Now instructions that will improve performance of some graphics applications.

Initial problems that were encountered in testing with the K6-2/400 have been cured with a patch for Windows 95 from Microsoft. Windows 98 users will have no prob-

lem running the K6-2/400 on Asus or other quality motherboards at the 100 MHz system bus speed.

Linux Gaining Favor Among Users

Several big technology companies plan to use Linux, a free operating system that is picking up corporate fans and showing signs of moving into the home market.

Dell Computer plans to collaborate with LinusCare Inc., a San Francisco company offering technical support for Linus. Hewlett Packard is discussing its work with a small Canadian company, Puffin Group to adapt Linus for H-P's main line of business computers. Inter-

national Business Machines Corp. is expected to give new details of its Linus work.

Also, Intel has taken a minority position in VA Research Inc., a company that sells computers configured with Linus and has secured rights to the Internet domain name, Linux.com.

Linus was invented by Linus Torvalds, a native of Finland, and refined with a global network of programmers. The operating system has long appealed to programmers, but it's speed, reliability and open development process have lately attracted Internet service companies and other corporate users.

Linus remains much harder to install and use than Microsoft Windows, and relatively few add-on programs are available in Linus versions. But developers are working on those problems.

Toshiba U.S. Laptop Losing Market Share

Toshiba has blamed recent management and inventory problems for having lost market share in U.S. sales of laptop computers. Toshiba pioneered the market for porToshiba pioneered the market for portable computers in the mid-1980's, and gained a wide following in corporate America for consistently incorporating the latest technological advances into it s computers. Toshiba was the first to market in laptops both Intel Corp.'s 486 microprocessor and the Pentium chip that replaced it.

Currently, Toshiba is tied with Compaq with 14.8% market share for portable computers sold in the U.S. In 1996, Toshiba's market share for laptop computers was 24.2%. This decreased to 20.4% in 1997 and now in the third quarter of 1998, is at the 14.8% figure. Toshiba has reorganized and beefed up its service and support and has revamped its product line to include more sleeker and rounder designs than the boxy ones before.

Officials estimate about a quarter of their laptops are now built to order, giving the company more flexibility in addressing a customer's needs than its former practice of prebuilding specific models to a forecast.

Free-PC Has a Waiting List

Free-PC Inc. announced plans to give away personal computers to people who agreed to share information about themselves and watch advertising, which may be based on monitoring their Internet activity. The results suggest that many people don't worry much about privacy. More than 100 people were waiting the first morning outside the offices of Idealab!, the Pasadena, California, firm funding the venture.


Consumers also called and left messages on every extension in the building, and jammed the company's Web site (free-pc.com). The company received 375,000 completed applications the first day for a planned giveaway of 10,000 units. If you missed out, don't despair. The first units will go to people who fit advertisers' desired demographics.

Netscape officials said the software dubbed "Gecko" after the small lizard, is faster and fits on a single floppy disk. It is aimed at embedding Internet browsing technology beyond the personal computer and into a wide variety of smaller information appliances and services expected to be used to access the World Wide Web in the future.

It is the first product based on contributions from outside developers after Netscape released the source code for its browser software on the Web to anyone who wanted it . The final version of Gecko will be available in early 1999 and will be deployed in the next edition of Netscape's full-featured browsers.

PCUG Tidbits from the Past*

In the 80's

The group incorporated March 6, 1984, under the name the Phoenix IBM PC User's Group.

Dues were higher, \$50 a year for new members and \$180 for corporate members

PCUG owned a color projector monitor. Members could rent it for \$75 per day, non-members for \$150.

The newsletter was just beginning to solicit advertisers, averaging 2 to 3 ads in each issue.

A Help Line was staffed by volunteers from 7 to 9 pm at one telephone number.

Monthly meetings in Mesa were canceled but meetings in Phoenix continued.

AUTOMENU was the featured disk in 1985, praised as the solution to the problem of learning all DOS commands

Workshops were held weekly. Registration ranged from \$15 to \$35 and members were urged to bring their own computers.

The group became the Phoenix PC User's Group in 1986 (unofficially) when IBM was dropped from the name.

It is our intention to continue this column as a "history" of your user group. Fifteen years is a fair amount of time to "be in business" and the newcommers to our group will gain an appreciation of who we are and how we got here by learning more about the group. As the history unfolds over the next few months, it will become clear that the group was built on volunterism and dedication to the user group motto "Users helping users to understand computers".

hen it was announced that Randy Johnson had signed for over \$50 million for 3 years to play for the Arizona Diamondbacks, Babe Ruth was probably spinning in his grave. But just as pro athlete salaries have gotten bigger every year, personal computing devices have gotten smaller and more powerful. This week Kim takes a look at these palm-sized dynamos; we check out another group of Kool Sites; and Kim shows you a "kool" tip about a neat little Easter Egg in MSIE 4.0.

Electronic Organizing

Paper-based organizers aren't extinct yet, but they're certainly headed in that direction. They owe their fate to a wide variety of electronic devices that make your personal information more portable and more useful than ever.

When you decide to bring your personal information into the digital age, you can spend a little or you can spend a lot. But no matter how much you spend, one of the key features to look for in any device is the ability to synchronize data with--or at least extract data from--your primary computer. In other words, you want to be able to maintain your appointment calendar on your PC and still take it with you in your digital toy.

In the \$100 range, you have a couple of choices. One of my favorites for some time has been the Timex DataLink (203-573-5000; www.timex.com) wristwatch. With the included software, you can maintain appointments, contacts, etc., on your personal computer and "beam" them directly from your monitor to a little eyeball on the wristwatch. Your monitor flashes what appears to be some sort of bar codes, and a few beeps later, all your personal information is on your wrist.

One of the shortcomings of the DataLink wristwatch is that data is a one-way street. Other than setting alarms and the time, there's no way to add contact and appointment information to the watch when you're out and

about. If you need something that can interact more fully with your personal computer, look at Royal's daVinci (888-261-4555; www.royal.com) that's also in the \$100 range.

The daVinci lets you update appointments, contacts, notes, etc., and then synchronize them via a cable connection with the corresponding information on your personal computer. The device is compatible with most major personal information management (PIM) software, like Microsoft Outlook and Symantec's Act.

To enter information on your daVinci, you have two options. You can use the daVinci's built-in handwriting recognition software and write your comments with the included stylus. Or for an extra \$20, you can by a folding mini keyboard to with the daVinci.

Moving up the price scale to about \$230, but down in the size scale is the Franklin REX Pro (888-739-6400; www.franklin.com). This handy little gadget is no bigger than a credit card, and only a little bit thicker. Like most personal information devices, the REX Pro lets you maintain calendars, to-do lists, contacts, and what not. You can take notes, too, but I wouldn't recommend it unless there's an emergency. To take a note, you have to select each letter individually, much like entering your name for the high score at the end of a video game.

What's most amazing about the REX Pro is how it communicates with your PC. You see, the REX Pro is actually a PC Card. That means that to download information from your laptop to your REX Pro, you just slot the entire REX Pro into the PC Card slot on your laptop. The only drawback here is that most desktop computers don't have PC Card slots. Therefore, if you're not a laptop user, the REX Pro might not be the best choice for you.

Finally in the \$300-\$800 range, you'll find gizmos that can generally be classified as true handheld computers. These fall into two categories: palm computers and handheld computers. 3Com (800-881-7256; www.palm.com) manufactures the entire palm computing family of devices, but handheld computers based on Microsoft's Windows CE operating system are produced by a variety of manufacturers.

The \$300 Palm III, 3Com's current model, offers a number of advantages over, say, the daVinci. Among them are larger memory for storing more information and the ability to send and receive e-mail through a modem connection. And since the Palm III is a true computer, there have been actual application programs written for it. In fact, hundreds of them are available for free as downloads on the Internet.

My Toolbox

I have a collection of utilities that I use daily, which may be helpful to some of you.

PrintKey

PrintKey version 4.0 is a great program to let you capture and print whatever appears on your screen. It's freeware, and is available from www.hotfiles.zdnet.com . Search for "PrintKey" and you'll find it. When I see a screen which contains information I want to save, I just open PrintKey and click on the icon to capture the screen. You can edit the captured image, save the image as a bitmap, crop the image, print the image, change the color balance, capture a color image as black and white, and do lots more. When you save the image, you can then attach it to an email and send it anywhere. If you are trying to explain something to someone else, just take a snapshot of your screen and print it or send it.

PrintKey takes a picture of the entire screen, from corner to corner. I'd pay good money for a program like this, and it's free! Many thanks to Alfred Bolliger, the person who copyrighted *PrintKey*, for developing such a fine application and placing it in the public domain. This one belongs in everyone's toolbox.

Servant Salamander

Servant Salamander is another freeware program. It lets you split your screen and show two views of a directory tree at the same time. This comes in very handy if you do a lot of file manipulation, and want to drag and drop files from one directory or folder to another. You can create directories, move files between directories, rename files and copy them to different folders, even across a network. You can use filters to select files of a certain type. You can edit files. You can find files. You can display different drives, or different folders on the same drive. This is what Explorer should be!

Aside from the unusual name, this application reminds me of the old Brooklyn Bridge program, Filer, which I still use in DOS to do the same things. *Servant Salamander* can be found by searching www.hotfiles.zdnet.com for the name "Servant."

SplitIt95

"SplitIt 95 is a small, simple program that allows you to split large files for easy transport on removable media. Just select a source file and a destination, then choose the size of the split pieces. You can select a check box for 1.44M floppy-sized pieces. In addition to the split pieces, SplitIt 95 generates a small batch file that reconstructs the original file. SplitIt 95 is very easy to use and — better yet — it's free."

How can I improve on the synopsis above which comes from the folks at ZDNET? Another handy program, especially if you don't have a Zip drive and need to move large files using only 1.44MB floppies. As with the utilities above, search for "SplitIt" at www.hotfiles. zdnet.com and you'll find this very handy application.

While you're at ZDNET's software site, there are thousands of other terrific programs which you may find very handy. The other day I needed an amortization program to calculate mortgage payments. A quick search under "amortization" came back with several files which fit the bill. Whatever you're looking for, I'd try ZDNET first. Another great location for downloading files is www.shareware.com . Shareware.com claims to have more than 250,000 files available for downloading. I'll take their word for it! But if you have a need for something in particular, browse to your heart's content and my guess is, you'll find it at ZDNET or Shareware.

Please keep in mind the difference between shareware and freeware. Freeware is freeB the authors expect the public to use their creations without any compensation. But shareware operates on the honor system. Try the software for free, and if you like it, please pay for it. If you don't like it, just take it off your system. By trying software in this manner, users are not out any money if the software doesn't meet the user's expectations. If the user is satisfied with the software, by paying for it the software developer has an incentive to support the software, improve it, or develop other software in the future. This is a win-win situation for everyone. Several major commercial applications started out as shareware.

Product Review: Tracter Pro

Do you need a faster way to retrieve information? Enfish's *Tracker Pro* may be the answer you're looking for—Info in a minute. From anywhere on your hard drive or the Internet.

Here's the review in a capsule: *Tracker Pro* installs on your hard drive. After installation, it spends an hour or more (depending upon how much data you have on your hard drive) looking at everything on your drive and building various indices. An index is just a list of all the different words that appear in documents on your drive. Once the indices are built, when you want to find all the instances where a specific reference occurs, you tell *Tracker Pro* to look it up, and you'll get a list of each document in which the subject word appears, and the first couple of sentences in the document.

Having indexed your hard drive in this manner, searching for specific information becomes quite simple. *Tracker Pro* can work with email, word processing documents, spreadsheets, presentation software, graphics files, browsers and PIMs (like Act!, Goldmine and Outlook).

Tracker Pro has many ways to sort and filter the information you request. Your initial request to find specific info (names, subject words, phrases) causes the program to create what is called a Tracker. There's a wizard to help you through this, although it becomes pretty easy very quickly.

Once you have created a Tracker to find all your references to taxes, for example, you can then filter all the references to *income taxes*. Once you have used the filter, your list will narrow down. If you're interested only in 1997 income taxes, any references to other years will be ignored. Then if you only wanted references to 1997 income taxes which appeared in your email, only those items meeting the narrowed selection criteria will appear. And you can filter even further by date. So if you want only the emails in a specific time period, you can accomplish it very easily. You can sort by any specific date, time period or day.

Once you have your results list, you can manage the list quite easily, sorting by name or subject, type of file (excel, word, Act!, etc.), date, path (location of file on your hard drive), and even by author of the document in which the reference appears. The listing provides a three line summary of the contents of each document, and has a See Also: section which refers you to other words which reference your subject word. A simple click on a down arrow

lets you see the entire reference to your keyword, without opening the application it came from. This means you can read a spreadsheet reference or word processing document without having to open up the original application. Pretty nifty!

The user has the option of searching tracked information for the items of interest, or searching the net using Excite, InfoSeek, AltaVista and Yahoo! In the next version of *Tracker Pro* it would be nice to let users add search engines to the Using box.

When I made a tracker for a family friend, it found references to the friend in Goldmine where I keep his name and address, and several times in Excel when I submitted quotes for jobs and invoiced him for work performed and items purchased.

Tracker Pro lets you add the electronic equivalent of sticky notes to your items. These cover notes stay with each item. You can open the notes by clicking on the little yellow note which shows writing on it.

You can track web sites with *Tracker Pro*, and have *Tracker Pro* notify you when a tracked web site has changed. You can do Boolean searches with *Tracker Pro* (a Boolean search lets you search using AND OR NOT and other logical operators).

I tested *Tracker Pro* on a Pentium 150 MMX laptop, and while it ran OK, it could have been a bit faster. When I read the manual I saw that *Tracker Pro* recommends a Pentium 166 as the minimum processor. *Tracker Pro* recommends 32 MB of RAM, although it will work with 16. VGA display with 256 colors, Windows 95, Windows 98 or Windows NT 4.0 or later are other requirements. You=II need at least 100 MB of free hard disk space before installing the program. The program requires between 2% and 3% of used hard disk space, and takes about 20 MB of room for its files.

The company has a website at www.enfish.com and you can purchase *Tracker Pro* directly from Enfish for \$80. You can download the program immediately, or have it shipped to you for some additional shipping and handling charges. The manual is easy to read, well written, and explains the features of the program.

Tracker Pro is very user friendly, and lets you customize just about everything to your heart=s content. If you have the room on your hard drive (and everyone today has plenty of room!), this could be an excellent time saver for you.

Sacramento County Superior Court Judge issued the preliminary injunction after Intel complained that mass emails to its employees constituted an illegal trespass into Intel's computer system.

The American Civil Liberties Union is concerned about the implications of this case and is considering appealing the ruling because they feel the court and Intel are muzzling the e-mail sender because they don't like what he is saying. In other cases, courts have backed Internet services that blocked users from sending mass e-mails through their systems, a practice known as "spamming." Most of these cases involved business promotions.

Scanner Pricing War


Upheavals in the scanner industry is prompting acquisitions and bankruptcies. Visioneer sold its hardware business for \$8 million to a subsidiary of Primax Electronics, A Taiwanese company. Then Visioneer acquired 55% of ScanSoft from Xerox in a stock swap. Meanwhile, fierce pricing wars in the scanner market claimed two victims when Storm Technology and Info Peripherals filed for Chapter 7 bankruptcy.

Analysts have said that retailers failed to merchandise the value of scanners and tended to focus more on price. Now scanners have practically been reduced to lowpriced value-adds for PCs. Many scanners are selling for less than \$100.

The demise of Storm Technology and Info Peripherals could leave some retailers stuck with inventory and no technical support for customers who buy the products. Product returns will likely have to be junked.

Very shortly, the \$450 Palm V should be available. (For whatever reason, 3Com uses only odd numbers.) Its biggest claims to fame are a thinner case, twice the amount of memory as the Palm III and a larger, easier to read display. What's more, 3Com has also already announced its plans for the Palm VII, due later this year and expected to cost as much as \$800. What you'll get for all that extra money is more connectivity. The Palm VII will be the first handheld organizer to provide complete self-contained wireless Internet-based communication.

A Windows CE handheld is more like having a real pint-sized personal computer in your hand. The Windows CE operating system was designed to give you a look and feel similar to Windows 95. What's more, these devices include so-called "pocket" versions of the Microsoft Office core applications, like Word, Excel and Internet Explorer. That means you can, for example, work on an Excel spreadsheet on your handheld and later transfer it to your desktop system for additional tuning.

Palm devices used to offer a slight price advantage over Windows CE handhelds, but that seems to be changing. As you can see, Palm prices are rising with increased functionality. However, a number of companies are offering Windows CE devices with color displays. This is pushing prices for older grayscale Windows CE handhelds down as to as low as \$200.

The next time you're ready to buy refills for your paper-based organizer, stop and think for a second. Maybe you should put that money toward a smarter electronic organizer instead.



Over the next few days, I told a few friends (experienced computer pros, and parents) about the experience which, of course, led to a discussion about porn on the net and child safety" online. Since that time, I've seen no less than five reports on television and press releases and announcements about new sites offering advice to parents continue to hit my in-basket. They'll tell you about spending more time with junior and sitting with our kids while they surf. They'll sell you books and subscriptions to newsletters about port on the net, all the while missing that first step.

So what is it?

Child Protection Software

For \$25-80 you can use products like Net Nanny, CyberPatrol, and Cybersitter to drastically reduce the amount of adult-oriented content that junior might be able to access. Restrict Web sites, chat sites and services, heck, you can even restrict shopping sites to make sure they don't go buying things with mom and dad's credit card. Net porn isn't just a problem for parents, however. Employees can end up using the corporate network to access "inappropriate" sites and services, utilizing your bandwidth and company time. Although it might be considered to be "child" restriction software, products like NetNanny do offer network versions for keeping porn out of the office-and for keeping the office out of the porn. Better still, for the corporate environment, there are organizations out there with products designed for protecting the network, like Infinite Technologies' Infinite Link.






I am proud to report that I have completed the "Y-to-K" date change mission, and have now implemented all changes to all programs and all data in production, to reflect the following new standards:


